\_\_\_\_\_ I have read and agree to the Handbook and Company Contract and understand the policies and its contents.

\_\_\_\_\_ Submission of debit/credit card information is required. Payment is due on or before the 1st of the month. **Non-payment and/or declined credit card will result in a \$25 late fee after the 5th of the month for each month the payment is late.** An additional **\$25 finance charge** will be assessed for accounts remaining delinquent after the **15<sup>th</sup>** of the month. Your athlete will sit out of practice until all monies are paid. **If your card information changes, you must fill out a new authorization form.** To avoid credit/debit card convenience fees you may opt to pay your bill in person via cash or Cashier's Check/money order **PRIOR to the 1<sup>st</sup> of every month.**

\_\_\_\_\_ I understand that COA Elite does not issue any credits or refunds on tuition and prepaid fees under any circumstances. **Tuition and fees are non-refundable.**

\_\_\_\_\_ **If you choose to leave the program, your account will automatically be charged the early termination fee of \$500 or fees as calculated by the Contract Buyout Option Agreement,** whichever is greater.

\_\_\_\_\_ I understand that tuition is a set monthly fee. I will owe the monthly tuition rate regardless of how many practices take place that month including all holiday breaks and gym closures. Likewise there is no charge for added practices.

I hereby agree that my/my athlete's **total season payment plan is \$**\_\_\_\_\_ and I agree to adhere to the payment schedule as listed on the COA Schedule of Fees.

Member(s) have a 15 calendar day period during which this contract can be cancelled. If Member(s) exercise their right to cancel within the specified period, this contract shall become VOID and any prepaid fees may be returned MINUS the registration fee and current month tuition. Any request for contract termination must be in writing and delivered to the Gym Director. After the 15 day period this contract shall become legally binding and Member(s) shall become subject to terms of Contract Buyout Option and/or Breach of Contract Penalty contained herein and the strict **no refund policy** shall be enforced. If the athlete joins late in the season, quits, or is removed for any reason, the signer of this agreement is still responsible for the full balance of this agreement unless otherwise specified in a separate Contract Buyout Agreement.
