## Competition General Information

Dear Advisor/Coach:

We appreciate your participation in our Claim to Fame Starstruck Competition. We look forward to a fun and enjoyable day of events. Please review the information below with participants and spectators.

### **ENTRANCE PRICES:**

0-1 years of age – FREE

2-5 years of age - \$5.00 (pre-sale) / \$10.00 (door)

6 and up - \$20.00 (pre-sale) / \$30.00 (door)

**NOTE:** All pre-sale tickets will be verified at the door and exchanged for a wristband. Any pre-purchased ticket not using the appropriate age bracket above will be charged for a new FULL PRICE ticket at the door. There will be two lines for tickets. "At the door" and "Pre-Sale". Pre-Sale ticket holders will be granted early entrance.

### **REGISTRATION PRICES:**

\$75 non-refundable deposit PER TEAM to hold spot **DUE BY OCTOBER 1, 2021.**

\$45 per dancer **DUE BY NOVEMBER 1, 2021.**

Pay via Eventbrite. Non-certified funds (checks) will not be accepted. NO CASH APP/NO PAYPAL.

**REGISTRATION WILL BE CLOSED ONCE WE RECEIVE TEN (15) TEAM REGISTRATIONS.**

## Competition General Information (CON'T)

- **TEAM CHECK-IN:**

- Teams should be on site and ready for check in TWO (2) hours before the doors open.
- Teams can walk the floor and get ready for first performance.
- Competition performance schedule will be in random order. Not based upon registration priority.
- All teams must be dressed THIRTY (30) minutes prior to performance time. **If you miss your performance time, the competition will not be held up for you.**

- **DRESSING AREA:**

- No personal dressing rooms/areas are available. All teams will be sharing dressing space. COA PRODUCTIONS WILL NOT BE RESPONSIBLE FOR LOST/STOLEN ITEMS. DO NOT LEAVE PERSONAL BELONGINGS UNATTENDED.

- **MUSIC:**

- **\*\*This may be the most important paragraph in this package. Failure to adhere to these guidelines may result in your team not performing\*\***
- All music must be uploaded to the Google Drive that will be provided closer to competition.
- As a backup - all music files MUST be uploaded to a Flash/USB/Jump Drive with each file clearly labeled (Team Name, Pom, Field, Hip-Hop. FOR EXAMPLE: COA ONYX.POM).
- No CDs or music played from phones or another electronic device. **NO EXCEPTIONS!**
- Once a team is on deck, the Coach should be in line at DJ booth ready with back up music drive.
- Any team causing a delay in the competition due to issues with music will be assessed a 5-point penalty to their team's overall score.

- **MISCELLANEOUS:**

- Team apparel does not grant free entry. ALL SPECTATORS (including non-performing dancers) must purchase a ticket.
- There will be no adding, cancelling, or changing of divisions on the day of the event. NO EXCEPTIONS.
  - ADD/CANCEL/CHANGE DEADLINE **JANUARY 1, 2022.**
  - Any change after this date will incur an additional fee of \$75.
  - **THERE IS NO REFUND FOR ATHLETES WHO WERE CUT AND DON'T PERFORM.**

Scoresheets will be available for pick up at the end of the competition.

Please remain seated while competitors are performing. DO NOT LEAVE BAGS UNATTENDED FOR SECURITY REASONS.

# Claim to Fame STARSTRUCK

## Code of Conduct/Dress Code: Dancers & Coaches

- Coaches must be dressed appropriately and professionally during all activities inside and outside of the competition.
- Coaches are required for each team and are responsible for the behavior of their dancers, parents, and support staff. These individuals are a representation of your organization. If any representative/participant of your group causes a disturbance during or after the event or is disrespectful to competition staff, your team(s) will be ejected and disqualified from future Claim to Fame events.
- Dancers are required to always be in a t-shirt, tank, or jacket that showcases their team's name.
- Parents of dancers are required to exhibit positive sportsmanship during all events held at Claim to Fame competitions. Failure to do so will result in ejection from the competition.
- Coaches are not allowed to antagonize or make any negative contact with the crowd or any other team's dancers/coaches. Coaches that engage in malicious or negative behavior will have their team ejected from the competition. NOTE: Rowdy fans will not be tolerated and will be ejected from the competition.
- Dancers must show respect towards all dancers of other teams, respect all rules, showcase great sportsmanship during the entire event.
- Coaches/Parents must always chaperone their dancers while maneuvering through the competition. Dancers shall never be unsupervised throughout the competition.
- Any team this is dismissed from the competition for any reason will receive NO REFUND on any monies paid for participation.
- Teams will be assessed a 10-point PENALTY for misconduct by a dancer, a 25-point PENALTY for parent/coach misconduct. EXTREME ACTS WILL FACE IMMEDIATE DISQUALIFICATION.

**\*\* A coaches meeting will be held to reiterate all of the above. Coaches will be required to sign an acknowledgement of their responsibility for their parents, staff, and dancers as well as the consequences for misconduct.\*\***



# Claim to Fame STARSTRUCK



## Category Descriptions

### TRIO

**Cannot exceed 3 minutes.** There are no theme requirements for this category. Tell your own story -- BRING IT TO LIFE!!! Routine can be any style of dance and is not limited to Majorette or Hip-Hop. Participants do NOT have to be team captains. **YOU CANNOT USE MORE THAN 3 DANCERS.**

### POM (Mini category maximum of 3 minutes)

**Cannot exceed 6 minutes.** This category is intended for the usage of poms. Poms MUST be used for the majority of the routine. Routines should be exciting, full of visuals, level changes, formation changes, and LOTS OF ENERGY! Show as many styles as possible.

### FIELD SHOW (Mini category maximum of 3 minutes)

**Cannot exceed 6 minutes.** Use this category to showcase Majorette/Hip-Hop/Jazz Funk high energy choreography that has an upbeat feel. Teams will be judged on variety, formation changes, and tricks. Band music is optional. How creative can you get?

### HIP-HOP (Mini category maximum of 3 minutes)

**Cannot exceed 4 minutes.** BE CREATIVE!!! No theme is required...JUST DANCE! Judges will be looking for complexity of dance, formation changes, tricks, exciting music, and visual execution. SHOW US WHO YOU ARE!

### CAPTAIN'S BATTLE

No more than THREE (3) captains max may participate. There will be TWO (2) rounds for Minis, THREE (3) rounds for K-6 and 7-12. One half (½) of the total teams competing in this category will be eliminated in the first round. The winner will be announced at the award ceremony. Captain's music will be sent out the first week of December (for PAID registrations).

### STANDS IN THE STANDS

Each team will dance to 1 entire song. Three rounds only (fast, medium, slow). Music will be provided. Songs will be a mixture of band music and popular R & B/Hip-Hop. Two teams will be eliminated after each round.

NOTE: SHOULD THE EVENT RUN INTO TIME CONSTRAINTS THE EVENT HOST RESERVES THE RIGHT TO LIMIT THIS CATEGORY TO ONLY ONE (1) STAND EACH ROUND. BE PREPARED!
